WE WORK TO PROMOTE PROPER INTERPRETATION AND IMPLEMENTATION OF THE INDIAN CHILD WELFARE ACT AND PROVIDE INFORMATION AND TRAINING FOR TRIBES SEEKING TO OPERATE TITLE IV-E CHILD WELFARE PROGRAMS.
